Sweden is one of the global forerunners leading the transformation towards a more patient-centred value-based system. Portugal has a similar strategy for and approach to patient empowerment. Focus on outcomes that actually matter to patients, along with advances in digital technologies create many opportunities to improve access to care, to reduce variation in outcomes, to increase health and social care quality, dignified ageing and to improve cost-efficiency.

As a follow up to the OECD Health Ministerial in Paris, our aim is to create a Portuguese-Swedish forum for best practice exchange and business dialogue in the important field of value-based health and elderly care. On the 16-17 January 2017, Health Ministers from over 35 OECD and partner countries exchanged ideas, ambitions and challenges for “The Next Generation of Health Reforms”.
